
## PLAISTOW AND IFOLD PARISH COUNCIL

#### Foxbridge - public consultation P/22/145

It was **RESOLVED** to seek traffic and planning expert advice upon receipt of the Outline Planning Application for the proposed health, eco-leisure, and accommodation destination at Foxbridge. The Council RESOLVED to instruct SW Transport Planning Ltd and Temple Group. The Parish Council has previous experience working with these consultants (Crouchlands Biogas) and has instructed them to support the Council in relation to any planning application(s) received regarding the Crouchlands Farm site (please refer to C/21/075, pg6.) The Council NOTED the potential adverse accumulative impact of both the Foxbridge and Crouchlands Farm sites on the local community and road infrastructure.
