
## PLAISTOW AND IFOLD PARISH COUNCIL

b. Three Oaks Farm, The Lane, Ifold, Loxwood, RH14 0UH, 20/02832/FUL.

The Committee noted the notification of the withdrawal of an appeal against the LPA's refusal of planning permission. The Committee understands that the landowner intends to erect large gates at the property. IEL intends to speak to the landowner and ask that they be set back away from the public highway.
