

 DBLP, Planning Agents acting on behalf of Artemis Land & Agriculture, will be applying directly to the Secretary of State for a SEA.

- b. District Councillor Evans queried with Andrew Frost the reasons why CDC are not notifying neighbours of planning applications. The response was lack of staff due to the pandemic.
- c. Pitsgate Hill lay-by will be used by the road re-surfacing contractors, instructed by IEL, for delivery and dispatch of materials during the works.
- d. Sunnydene, Ifold has been sold. The Enforcement Notice remains with the property. It is noted that the gateposts remain in breach.
- e. Oxencroft, Ifold the PCN was put on hold whilst the PD
