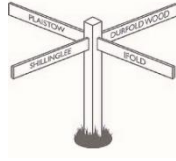

1. Introduction

In line with the National Planning Policy Framework (NPPF) and the Chichester District Council (CDC) Local Plan Key Policies 2021–2039, the Plaistow and Ifold Parish Council undertook the preparation of a Neighbourhood Plan (NP). This document outlines how consultation was carried out with residents, landowners, and stakeholders across the four parish settlements: Ifold, Plaistow, Durfold Wood, and Shillinglee.

As required under Regulation 15(2) of the Neighbourhood Planning (General) Regulations 2012, this Statement of Consultation includes:

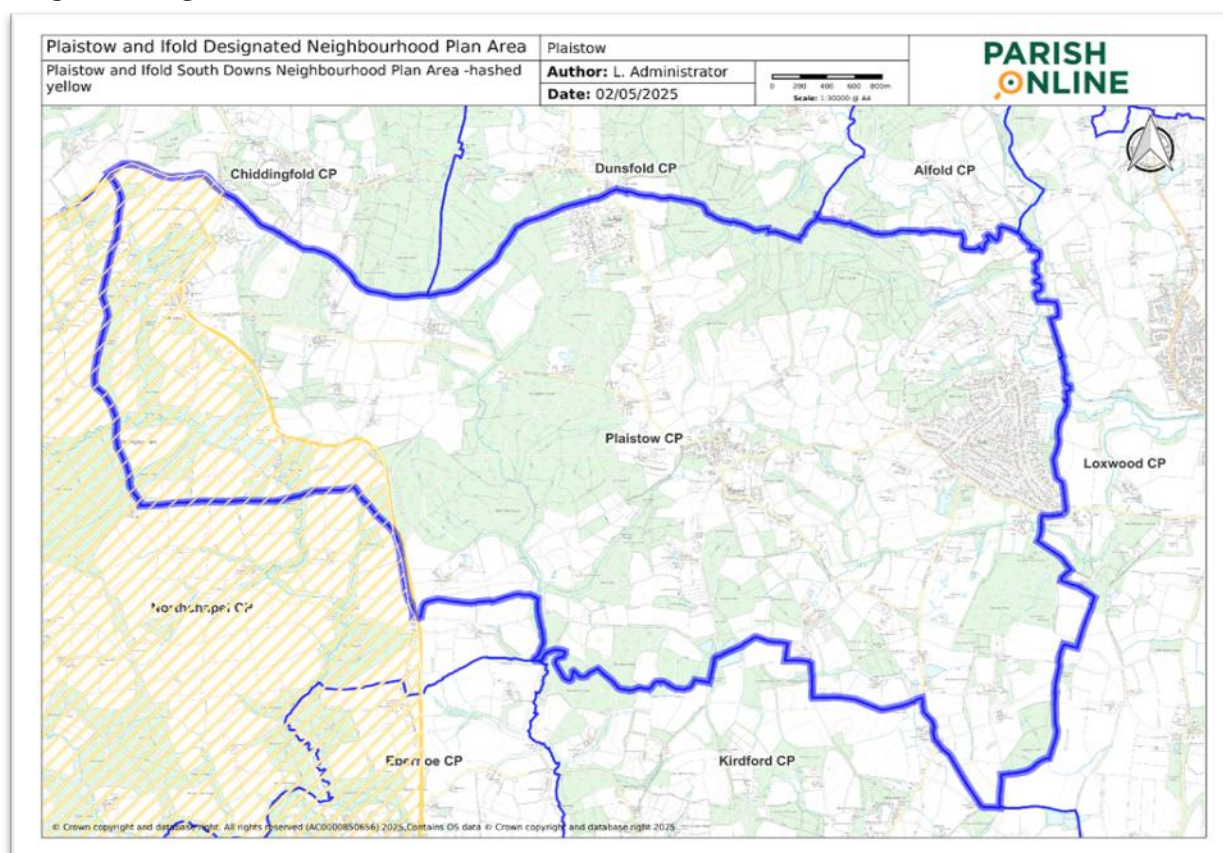

2. Background

Plaistow and Ifold Parish is located in the northeast of Chichester District and spans over 20 square kilometres. The parish includes open farmland, ancient woodland, and four primary settlements: Ifold, Plaistow, Durfold Wood, and Shillinglee.

On 26 June 2012, the Parish Council resolved to designate the area of the civil parish as the Neighbourhood Plan area. The application was submitted to CDC on 2 July 2012 and the designation was confirmed by CDC on 6 November 2012.

Designated Neighbourhood Plan Area



Initial work began in 2013 but was later withdrawn from Examination in February 2022 due to the issues raised by Natural England of water neutrality in the Habitats Regulations Assessment. A new NP began in August 2023 following a formal resolution by the Parish Council. The Parish Council resolved not to allocate residential development sites but to support CDC's Local Development Scheme (scheduled for Autumn 2025). The Parish Council recognised that proposals from the previous aborted NP needed to be revisited, validated and reconsulted upon. A planning consultant was engaged, and funding was secured.

3. Stages of Public Consultation

The extensive work on the previous version of the NP which commenced in 2013 was not entirely discarded and the extensive consultation exercise and feedback on the 2013 NP is referenced and included to support the 2023 NP Policies and Aims. The Statement of Consultation table accompanying the 2013 Statement of Consultation sets out Consultation events and references actions arising from feedback and is included here for completeness. (Appendix C)

December 2023: Scoping and Evidence Gathering

On 7 December 2023, a public consultation event was held at Winterton Hall, Plaistow. Approximately 50 residents attended. Presentations were delivered by the Planning Consultant and AECOM. Residents responded to seven key questions. Further online consultation followed in March 2024. Responses are summarised in Appendix I and informed the Design Guidelines. (Appendix A)



March 2024: Housing Needs Assessment

AECOM completed a desktop Housing Needs Assessment, adopted on 13 March 2024. It is published as Appendix B of the NP.

April 2024: Design Guidelines

Following site visits and community feedback, AECOM produced Design Guidelines, adopted on 12 June 2024. This was updated by AECOM in December 2025 to incorporate amendments as a result of the NPPF December 24 and the Chichester

Local Plan Policies adopted in August 2025. The update Guidelines were adopted by the Parish Council at their Full Council Meeting on 7th January 2026.

May 2024: Annual Parish Meeting

An update on the progress of the NP was provided at the Annual Parish Meeting (Appendix II). Approximately 35 residents attended. Questions focused on the housing requirement for the Parish.

January 2025: Non-Designated Heritage Assets (NDHAs)

On 21 January 2025, the Parish Council Working Group evaluated NDHA proposals using Historic England's Advice Note 7. Property owners were notified in writing of the intention to consider applying to CDC for their inclusion on the CDC NDHA List. The proposals arose out of consultation with the Plaistow Village Trust and also the Ifold History Society arising during the preparations of the previous 2013NP.

June 2025: NDHA Policy Formation and Owner Notification

On 17 June 2025, the NP Working Group met and assessed NDHAs against the CDC NDHA matrix to inform policy development. Properties scoring 5 and above were suitable for inclusion in the Policy. Following this meeting, property owners were contacted to advise them of the Policy proposal informing them of what this meant to them in practice and of the informal consultation covering July and August 25 and later formal Regulation 14 Consultation in the autumn.

January to March 2025: Local Green Spaces Consultation

The short list of Local Green Spaces arose out of the evidence gathering for the 2013 NP. This list arose firstly from a Call for Sites in January and February 2016 and then a questionnaire was sent out over the period January to March 2016. 803 questionnaires were sent out and 268 were completed. A further consultation was held on 2 July 2016 in the form of a pop-up stand at the school fete. The stand was advertised through the school and Parish Council website and notice boards. The list generated during the 2013 NP process was approved at the Parish Council meeting on 21st January 2025.

This list was then further consulted upon via the Parish Council website, and this was communicated to residents via the website, newsletters, and Facebook. (Appendix IV).

June 2025: Final Local Green Spaces Site Selection and Owner Notification

Following a review of the consultation feedback, selected sites were proposed as Local Green Spaces. Landowners were notified, following the NP Working Group meeting on 17th June 25, of the decision to designate the sites as Local Green Spaces for informal consultation in July and August 25 and formal Consultation in the autumn and the reasons for this designation.

May 2025: Annual Parish Meeting Update

Another update was presented at the Annual Parish Meeting. Around 35 residents participated. Housing remained a key topic (Appendix V).

July to August 2025: Pre-submission Plan Informal Consultation

Preliminary consultation on the draft Neighbourhood Plan was undertaken with residents and neighbouring parishes over July and August 25. The NP was published on the website and this publication was advertised via. The website, via Facebook, Church Newsletter, E-Newsletter sent to the E contact list and placed in village shops as a hard copy (Appendix VI).

29th October and 26th November: Drop in Events in Plaistow and Ifold



The drop in events were advertised via the website, Parish Council E- News, Church Newsletter, Facebook, notice boards and six banners put up around the Parish. Councillors did their best to advertise and encourage attendance at the biannual litter picking event the week before.



The events consisted of displays on boards across the five areas:

- Housing
- Economy & Employment
- Community Assets & Recreation
- Water
- Environment & Community Connectivity

The displays provided snapshots of the content in the Draft Neighbourhood Plan with the option of commenting on the boards or looking at the full documents online.

Approximately 22 people attended the Plaistow event and 30 attended the Ifold event held in the village halls. The online consultation continued until 10th December 2025

Regulation 14 Consultation 2nd February 2026 to 31st March 2026.

The Parish Council approved the updated Neighbourhood Plan for Regulation 14, amended following the Autumn 25 consultation at the Full Council meeting on 7th January 26. Statutory Consultees were notified by:

NEIGHBOURHOOD PLAN: FORMAL CONSULTATION

Regulation 14 Plaistow and Ifold Neighbourhood Plan 2023-2039

A community-shaping moment is approaching for Plaistow and Ifold. From 2 February 2026 to 31 March 2026, residents will have the opportunity to take part in the formal Regulation 14 Consultation, which is the first statutory consultation on the Plaistow and Ifold Neighbourhood Plan 2023-2039. This is the stage where the community's voice matters most. The draft Plan sets out local priorities for housing design and layout, green spaces, travel and infrastructure, and the long-term character of the parish. The consultation invites every resident to review these proposals (which have been updated since the summer/autumn 2023 consultations for those who have commented before) and share views before the Plan is finalised and sent to Chichester District Council. CDC will then review and carry out their own consultations on the document.

Taking part is straightforward and genuinely influential. Every comment will be responded to in a consultation statement and published on the website. This statement will then accompany the Neighbourhood Plan through the remaining stages until adoption of the Plan as Planning Policy for our local area.

The consultation materials - the full draft Plan with supporting appendix, and response forms - will be available online - and in hard copy by request.

4. Analysis of Evidence and Impact on Strategy

- **December 2023 Event:** Responses are summarised in Appendix I. Their influence on the strategy is outlined in Appendix VIII.
- **Local Green Spaces Consultation:** 41 responses were received. Outcomes are incorporated into the Plan and detailed in Appendix VII. Owner responses are noted in the summer 25 draft NP informal consultation responses. (Appendix X)
- **NDHA Consultation:** Property owner responses and their impact on the NDP are outlined in Appendix IX with comments from the Informal consultation carried out over summer 2025.
- **Comments from the informal summer 25 NP** consultation are available with feedback at Appendix X
- **Comments from the October and November 2025 and the following online event to 10th December 2025** are available with feedback at Appendix XI. As well as over 50 individuals attending these events the number of visits to the NP page on the website increased significantly during October and November 2025. September users of the page were 20. This rose to 59 and 40 in October and November respectively.
- **Comments from the Regulation 14 Consultation** are available with feedback confirming changes to the Plan at Appendix XII

5. Engagement with the Local Planning Authority (CDC)

CDC, as the lead planning authority, provided guidance and review support.

April 2025: Meeting with CDC

On 28 April 2025, a virtual meeting was held between the CDC Neighbourhood Planning Officer, the Planning Consultant, and the Parish Council Clerk to discuss the progress of the NP and likely dates for the Regulation 14 Statutory Consultation.

November 2025: Catch up with CDC

On 28th November the Parish Council Clerk met online with the CDC Neighbourhood Planning Officer to discuss the progress and future timeline of the Neighbourhood Plan.

April 2026: Team meeting with CDC following Regulation 14.

On 9th April 2026 the Parish Councillor Andrew Woolf the NP Planning Consultant M Williams and the Parish Council Clerk Jane Bromley met with the CDC NP Officer Valerie Dobson to discuss the comments from CDC at Regulation 14 and for the Officer to address queries from the Parish Council other comments received as set out in the Notes to the meeting.
